BLACK FRIDAY OFFER: 50% discount from 2000 EUR to EUR 1000 per breeding.

Please note that NO VAT applies. A **limited amount of 10 breedings** are available on a first come, first serve basis.

Transfer has to be made via the website (Paypal or Credit Card). Payment secures booking of breeding. The offer is valid from 29.11.2019 until 1.12.2019 Midnight (**Payment has to be made until 24.00 on 1.12.2019 Central European Time**).

The term of this contract is ONE breeding season: 2020.

NB Arabians reserves the right to deny the breeding to anyone, in which case the paid fee will be transferred back and the contract

GENERAL TERMS OF THE BREEDING CONTRACT

The breeding fee does not include the cost for the doses of frozen semen, transport fees, import taxes or any other fees related to the breeding.

For one breeding 3 doses need to be purchased for the production cost of 250 EUR.

Additional doses can be purchased on request.

Frozen Semen is available for the following countries – should your country not be listed, please check with us and we will happily check if we have the tests required for your country. United States of America, United Arab Emirates, Saudi Arabia, Kuwait, Kingdom of Morocco, Israel, Egypt, Qatar.

Mare Owner shall send their nitrogen tank to the clinic where semen is stocked in order to receive semen or can be rented from the clinic at the cost provided by the clinic where the semen is stored.

Stallion owner shall provide semen from Stallion identified in this contract and makes no other guarantee of the condition of the semen once the nitrogen tank has left the clinic.

This contract specifies frozen semen.

The Mare Owner acknowledges that breeding/breedings are non-transferable and cannot be re-sold to any other party.

The Mare Owner shall be responsible for semen storage, proper handling and insemination into the mare.

IMPORTANT: in order to facilitate the editing of the breeding certificates, the Mare Owner has to inform the Stallion Owner as soon as pregnancy has been confirmed.

Should the mare fail to conceive, should she abort or die, then the Stallion Owner guarantees that the Mare Owner shall have the right to rebreed or substitute the mare within the current or the following breeding season. Mare Owner shall be responsible for all fees involved with handling and shipping of semen (production, handling, health certificate and shipping).

If a mare fails to settle after two seasons, for any reason, Mare Owner will hold Stallion Owner blameless, and the present contract shall be considered fulfilled. The semen purchase fee under this contract will be fully earned and nonrefundable.

In the event that mare does not produce a live foal or the foal dies within 45 days after birth, the Mare Owner shall provide the Stallion Owner with a veterinarian's certificate stating the birth, time and date of death, and cause of death within seven days of aforementioned death.

In the event that mare dies, Mare Owner shall provide Stallion Manager with a veterinarian's certificate of death.

THIS BREEDING PROPOSAL IS VALID FOR THE 2020 BREEDING SEASON. SHOULD THE MARE OWNER AGREE WITH ITS TERMS AND DECIDE TO PURCHASE THE BREEDING, THEY MUST RETURN THIS CONTRACT DULY FILLED TO THE STALLION OWNER.
